### Minutes Pending Formal Adoption by Council

Purpose of Meeting: In-person quarterly meeting of the Via Hope CPS Advisory Council

### Update on HB 1486

Dennis Bach presented an update on what the HB 1486 workgroup has been working on. He discussed the implementation schedule, information on the new training and certification model and how CPSs who are currently certified will be grandfathered into the new system. ### Discussion of CPS Advisory Council term lengths, possibility of reapplying following term

The group unanimously voted to extend CPS Advisory Council terms to three years beginning with the current membership. Members voiced that an additional year will allow for leaders to have more time to orient to the council and get more meaningful work done before their terms expire. The council moved to have an agenda item added to the October meeting to continue discussion on when council members can reapply after their terms end.

#### **Discussion of Peer Support Day celebration**

The International Association of Peer Supporters (iNAPS) has established an annual Global Peer Support Celebration Day, which will take place on October 18<sup>th</sup> of this year. Prior to the meeting members had expressed interest in celebrating this occasion by pursuing getting a declaration/proclamation made honoring the occasion in the State Legislature. The group discussed this idea and brought up ideas for



how to celebrate on the local level. Lisa Pous offered to research what is involved in getting a proclamation or other such recognition made by members of the legislature.
